THE GARDEN ROUTE ADRENALINE TOUR DISCLOSURE:

The Garden Route Adrenaline Tour is an “extreme tour” in that it offers the opportunity for its participants to partake in activities both optional and inclusive, which may expose the undersigned participant to high risk situations despite the fact that measures have been taken to ensure the participants utmost safety and wellbeing. Such activities would include; Great white shark and crocodile cage diving, various high-speed water activities, wild animal encounters, adventure caving, skydiving, bungee jumping, motocross as well as various other similar extreme activities.

For the purposes of this release the activities offered on and partaken in on THE GARDEN ROUTE ADRENALINE TOUR will be referred to collectively as the “activities”, and the owners, staff, management or any other person forming part of THE GARDEN ROUTE ADRENALINE TOUR will be referred to collectively as “THE GARDEN ROUTE ADRENALINE TOUR”.

I hereby agree with the following terms and conditions of operations and indemnity:

I hereby indemnify and hold harmless THE GARDEN ROUTE ADRENALINE TOUR and all other persons against all actions or claims by me arising from participating in the tour and any of its offered activities.

I understand and acknowledge that the activities have inherent dangers and certain elements of unpredictability that no amount of care, caution, instruction or expertise can eliminate and I expressly and voluntarily assume all risk of personal injury, mental anguish, or death, whether foreseeable or not, sustained in connection with participating in the activities, including in consequence of the negligence of the owners and/or operators of the activities.

I thus voluntarily release, discharge, waive and relinquish any, and all claims or causes of action, especially delictual claims including, but not limited to, those arising out of or in connection with my participation in the activities offered by THE GARDEN ROUTE ADRENALINE TOUR.

I undertake to comply with all reasonable instructions issued by the person(s) lawfully charged with authority and control of the tour.
